Water Rights Solutions-Colorado's climate is arid and many rivers are over-appropriated. This often causes rivers to suffer from low-flows, or no flow at all. These conditions stress the environment and the communities that rely on rivers as their lifeblood. One solution is to repurpose senior water rights to enhance flows for rivers in need. The Colorado Water Trust and its partners work with willing owners to acquire senior water rights, gain the necessary approvals under the state water law system, and commit the water rights to instream flow purposes.

The Colorado Water Trust provides consulting services to municipalities, land trusts, water user associations, and other groups looking to restore and protect flows in their local river. The Colorado Water Trust can confidentially evaluate water rights portfolios for streamflow restoration potential, help local groups understand flow restoration opportunities in their basin, and educate land trusts about the intersection of flow restoration and land conservation.
